


DOT EXAMS AND RECERTIFICATIONS

According to the U.S. Department of Transportation (DOT), **the most important safety feature of any commercial vehicle is the operator.** This means drivers of trucks, buses, and other large vehicles on U.S. public roads must be physically fit and fully capable of controlling these machines. Drivers prove this capability every two years by taking what is officially called the DOT Medical Exam and Commercial Motor Vehicle Certification, commonly known as the DOT physical.

Note: DOT exams are not a replacement for annual wellness exams.

WHAT DO I NEED TO BRING TO THE EXAM?

You should plan to bring your current license(s) and another piece of photo identification. Also bring any prescription eyeglasses, contact lenses, hearing aids, or limb prosthetics. If you are taking prescription medication, bring any supporting documentation from your prescribing physician(s) and be able to provide their full names and contact details. You'll also receive a vision and hearing test.

Common documentation you may need:

- High Blood Pressure: most recent medication list
- **Diabetes:** most recent Hemoglobin A1-c and medication list (if taking medication)
- Sleep Apnea: CPAP compliance report from the past 3 months
- Cardiac Issues: need most recent cardiac records from
 Cardiologist to include any testing that has been performed
- **Chronic Pain/Medical Issues:** most recent medication list and any documentation from their treating physician as to why they are on medication

HOW DO I SCHEDULE THE EXAM?

HOW SHOULD I PREPARE FOR THE EXAM?

The DOT physical exam tests for two of the most common health problems in the U.S. - diabetes and hypertension (high blood pressure). Indicators of these (and other) health conditions will appear in your urine sample, but it is relatively easy to take a few steps to reduce these indicators before your test.

Note: In order to receive a two-year certification, drivers must have a blood pressure (with or without medication) at or below 140/90. If it is greater than this, you may be required to re-certify sooner.

It is also advisable to sleep as well as possible in the 48 hours before the test. This, in addition to the reduction of nicotine, caffeine, and sodium, should keep your blood pressure low during the test. And, of course, prepare your documents in advance and give yourself plenty of time to get to the test — anything to avoid rushing around and raising stress (and therefore blood pressure) levels.

The most common advice is to reduce your intake of salt, sugar, nicotine, and caffeine in the 48 hours before the test. Also, drink a lot of water to stay as hydrated as possible in the 24 hours before the test. These actions will ensure that the water volume of your urine is high, and the concentration of any indicators is low.

Finally, it is important to be as transparent as possible in the exam, and answer questions completely. Much of the test involves self-reporting past or existing medical conditions, and while it may be tempting to simply not mention something, the penalty for nondisclosure or providing misleading information can be severe, ranging from the loss of one's license to criminal charges.

HOW MUCH WILL THE EXAM COST?

\$100 for the exam only

\$140 for the exam and drug screen

\$40 for drug screen only

NOTE: DOT physicals are not able to be billed to insurance
