## HEARING AIDS

- > Our audiologist works with hearing aids from six different manufacturers: Phonak, Unitron, Signia, Oticon, Starkey, and ReSound.
- > Hearing aids come in different styles, ranging from in-the-ear devices to behind-the-ear devices
- > Depending on your hearing loss and lifestyle, the audiologist will recommend a style that best fits your needs.

## COMMON QUESTIONS

### What is an audiologist?

Audiologists are licensed, doctorate-level health care professionals who evaluate, diagnose, treat and manage hearing loss and balance disorders in both adults and children.

### Do I need a referral to see an audiologist?

Yes, most insurance plans require a referral for a hearing evaluation and communication and functional needs assessment.

### What are common signs of hearing loss?

- > Inability to hear people clearly and fully
- > Frequent requests for repetition or clarification
- > Fatigue at the end of the day from straining to hear
- > Avoidance of social situations because of difficulty hearing in noisy environments
- > Family members mentioning the television volume is too loud

### How much do hearing aids cost?

At Solvera Health, prices for:

#### Non-rechargeable hearing aids

Range from \$1864/pair to \$5608/pair

#### Rechargeable hearing aids

Range from \$2158/pair to \$6024/pair

### Will hearing aids be covered by insurance?

Not all insurance plans provide a hearing aid benefit; however, our registration team at Solvera Health will verify your benefits prior to you being seen by the audiologist.
